**RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE DIRT KINGS TOUR, LLC, the promoters, participants, any other participating racing association, any sanctioning organization or any subdivision thereof, track operators, track owners, officials, vehicle owners, drivers, pit crews, any persons in any restricted area, sponsors, manufacturers, suppliers, advertisers, owners and lessees of premises used to conduct the EVENT(S) and each of them, their officers and employees, all for the purposes herein referred to as "Releasees", from all liability to the Applicant, his/her personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the Applicant, whether caused by the negligence of the "Releasees", or otherwise while the undersigned is in or upon the restricted area, and/or competing, officiating in, observing, working for, or for any purpose participating in the EVENT(S).
