I acknowledge and assume all responsibility for any charges, record keeping, premiums, and taxes, if any, payable on any funds I may receive as a result of my activities as an Dirt Kings Tour, LLC member, including but not limited to social security taxes, unemployment insurance taxes, workers' compensation insurance, income taxes and withholding taxes.

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT
